



**ASSOCIATE MEMBERSHIP REQUIREMENTS:**

1. All applicants will be required to complete a membership application and fulfill a minimum of one calendar year as an Associate member. This will allow associate members time to meet club members and experience the club first hand;
2. Complete a Carolina Australian Shepherd Club Membership Application in its entirety. Signature(s) are required on the application to certify applicant(s) agreement to abide by the Code of Ethics, Constitution & Bylaws, registry rules & regulations, program rules, and dispute resolution rules of both ASCA and CASC;
3. Associate members must pay the established annual dues at the time the membership application is submitted to the membership coordinator.
4. Associate members do not have voting privileges at club meetings.

**Note:** For those persons under the age of 18 years, there shall be junior membership, which shall not carry any voting privileges. Additionally, current CASC members with full voting privileges will mentor Associate members. Mentors will guide the Associate members and assist them to learn about the club processes and how to manage an efficient ASCA event, thereby helping the club to grow.

**FULL MEMBERSHIP REQUIREMENTS:**

Once Associate members have fulfilled the above requirements, they may request full membership as follows:

- Renew their membership application and pay the set annual membership dues;
- If the applicant(s) are members of the Australian Shepherd Club of America (ASCA), they must be ASCA member(s) in good standing.
- A reading of the membership application will be held at the next CASC meeting following the submission of an application requesting full membership and the CASC membership will cast a vote.

**NEW MEMBERSHIPS & RENEWALS:** Membership includes the club e-newsletter and if members do not have e-mail a newsletter will be provided by US Mail. By completing this CASC membership form, you agree to abide by the Code of Ethics, Constitution & Bylaws, registry rules & regulations, program rules, and dispute resolution rules, of both ASCA and CASC.

All members that are also members of the Australian Shepherd Club of America (ASCA) must be ASCA member(s) in good standing.
